PRELIMINARY SCORED BILLS

June 2013

The RI Center for Freedom & Prosperity reviewed all legislation submitted this session (**as of June 21**), scoring each bill with regard to its effect on freedom and, particularly, whether it would further contribute to or would begin to alleviate Rhode Island's state of decline. In total, we are tracking **592** bills, with a total weighted score of **-323**, meaning that if all of the legislation were to pass, the overall effect on the state would be a negative one.

Note that this is a preliminary list. Upon the end of the legislative session, the Center will review all of the legislation for the accuracy of the descriptions. We will also present all bills that receive floor votes to a panel for final judgment concerning whether each bill is positive, negative, or neutral and what its weighting ought to be.

2-aa		to postpone the merger of the Board of Governors for Higher Education and the Board of Regents for Elementary and Secondary Education until March 7, 2013
9		to interfere with the relationship between merchants and electronic payment systems (mostly credit and debit cards) by forbidding negotiated contract terms such as pricing signage, discounts/incentives for using certain forms of payment, and selective use of the services at different locations
11	5269	to exempt new businesses from the franchise tax for their first 3 years, and then to give them a \$100 credit toward the tax for each employee, up to four. Those not organized as S-corps would still be liable for the \$500 min income tax; currently they do not pay franchise tax unless it exceeds the income tax
12-SubAaa		to allow public schools to host gender-specific activities (such as father-daughter dances), as long as "reasonably comparable" activities are hosted for the other gender
13	5055	to exempt school districts from paying the local share of a student's tuition to charter schools and other non-district public schools if the "comparable district school" outperforms it according to the state accountability system
16		to require the governor's proposed budget to justify expenditures beginning from a zero base (as if every department were requesting money for the first time). This bill would also create a three-legislator panel to review the proposed budget and review the requests
19-SubB	5364	to allow the state government or a public corporation to refund bonds, financing leases, or loan guarantees without the approval of the General Assembly
20	5137	to repeal the law transferring ownership of Sakonnet River Bridge and the Jamestown Verrazzano Bridge to the Bridge and Turnpike Authority, adding language to explicitly forbid tolls on the Sakonnet River Bridge
21		to require cities and towns to follow a statewide system of accounting
22	5249	to free estates from taxation if their total value is less than \$2 million. (Currently, the threshold is \$850,000) The legislation would increase that threshold annually in accordance with the inflation
23	5194	to eliminate the state capital gains tax on ownership investments in Rhode Island companies greater than \$10,000 that are held for at least three years

29-SubA	5303, 5371 & 5748	to screen Medicaid, Rite Care, and Rite Share benefit claims and to analyze all transactions looking for fraudulent or incorrect claims
38	5015	to redefine marriage to include same-sex couples, with no protections for individuals or organizations who recognize only marriages between a man and a woman, except in extremely narrow religious circumstances
39	5496	to eliminate the option on state election ballots to vote for every candidate from a particular political party --- known as "master lever" and "straight party ticket" voting. This legislation is incomplete and therefore inferior to S0044
40	5284	to reduce the interest charged on civil action damages from 12% to 6% per year
41	5205	to collect DNA samples for any person arrested for a crime of violence (currently, DNA samples are only collected for those convicted) and expands the list of crimes for which a DNA sample is required
43	6231	to forbid Rhode Island courts from allowing a parent custody or visitation rights of a child conceived in an act of rape for which that parent was convicted, unless the "natural mother" or legal guardian consents to allowing limited, supervised visitation. The legislation would also apply to statutory rape of children under sixteen
44 & 653	5072 & 5778	to eliminate the option on state election ballots to vote for every candidate from a particular political party --- known as "master lever" and "straight party ticket" voting
46	5150 & 5533	to make it easier for the state to fine Rhode Islanders between \$350 and \$750 dollars for driving unregistered or uninsured automobiles. The system used for this purpose would include an "automatic license plate recognition system" that uses video cameras to identify a vehicle's license plate. It would also include a database to increase the ease with which government employees can request information about a vehicle and require all insurers to report to the state every day on customers who purchased or cancelled insurance or allowed their payments to lapse
49	5066	to move the deadline for notification that a teacher may be dismissed at the end of the school year from March 1 to June 1 if the reason is for a "fiscal exigency or program reorganization "
62		to make the general officers and board of directors of a private higher-education school personally liable for refunds of deposits and tuition payments if it closes without giving at least thirty days' notice
63		to give the state Renewable Energy Coordinating Board the authority and mandate to "provide a forum" for supporting "sustainable community development" and green jobs
65		to make the \$850,000 threshold for the estate tax into an exemption so that Rhode Islanders would only be taxed on assets above that amount. Currently, they are taxed on the entire estate if it is greater than that amount
66 & 195	5095 & 5117	to remove the sales tax from pet-care services
67 & 264	5218	to remove the sales tax from taxi services
68	5217	to use state taxpayer money as incentive for cities and towns to spend more local taxpayer money on senior services
71		to eliminate the minimum corporate income tax and minimum franchise tax on capital assets

79		to require metal-recycling businesses to apply for a license from the state, at a cost of \$70 per year. This bill would also impose stringent regulations concerning the identities of everybody from whom recyclers purchase metal and would make them liable for total damages if the metal was stolen and the regulations are not followed precisely
81	5470	to raise the threshold for the estate tax from \$850,000 to \$1 5 million, but would not make it an exemption. This means that estates over the threshold would be taxed on their total value, not just the value over the threshold
85	5413	to reduce the state gasoline tax from thirty-two cents per gallon to twenty-seven cents per gallon
87		to increase the income tax handout for the Earned Income Tax Credit from 15% of the amount that the credit exceeds the person's tax burden to 100%
89		to implement a \$5 co-payment for Rite Care/Rite Share members who utilize hospital emergency rooms and make urgent care visits
91		to require the General Assembly to include "legislative grants" in the state's annual budget. Currently, House and Senate leaders have near complete discretion in handing out this money
92		to forbid health insurance companies from seeking to lower costs by requiring members to use alternate prescription or over-the-counter drugs before using brand names, unless the alternate is a "therapeutically equivalent generic drug "
97		to free contractors from the requirement to notify clients of the contractor's right to file a mechanics lien on the property if they are not paid
98		to add "government assistance recipient" as a protected class in matters of housing discrimination. This legislation would not apply to rental properties with three or fewer residences, one of which is occupied by the owner.
100	5046 & 5301	to force tradesmen who maintain electrical wires and equipment to acquire electrician licenses
102		to require employers to pay transportation costs for employees receiving health care services related to a workers' compensation claim
103	5198	to present voters with a Constitutional amendment that would require all elected officers in the General Assembly and executive branch to pay 20% of their health insurance premiums
110		to force all financial institutions and credit unions to install security video cameras on their own premises at night deposit repository areas
111 & 309		to exclude wireless providers from the jurisdictions of the Public Utilities Commission and the Division of Public Utilities and Carriers
112	5138	to allow Rhode Island public schools to increase their budgets by forcing parents above a certain income level to pay for students' extracurricular activities unless they can persuade the district that financial or personal hardship make payment impossible
113		to mandate musical performance instruction (including band, chorus, or other instruments) in all Rhode Island public secondary schools, without providing any funding
114		to make school bus monitors optional for district buses carrying students through fifth grade. The law currently requires districts to hire bus monitors to ride along with bus drivers
115		to postpone the merger of the Board of Governors for Higher Education and the Board of Regents for Elementary and Secondary Education until the General Assembly and governor approve an administrative plan
116-SubA		to give school districts the flexibility to extend their school days in order to shorten the number of days in the school year. The legislation also allows districts to exceed the number of total hours that would be required

117	5277	to forbid the Department of Education or any school district from using standardized testing as a criterion for graduation. Instead, the tests would only be used for school "accountability and improvement" and as a trigger to notify parents of their children's low performance
118-SubA	5252	to create a state "Teachers' Advisory Council" populated with teachers from every district appointed by their unions that would provide an additional platform for teachers' interests in front of the Board of Regents or equivalent committee
119	5475	to require recipients of public cash and medical assistance to ensure that their children have at least an 80% attendance rate at school, not including absences due to illness and injury
121		to impose new regulations on the sale and installation of outdoor wood-fired hydronic heaters
122	5378	to further implement separation of powers by removing members of the General Assembly from the Coastal Resource Management Council. Membership rules would also be simplified and changed with the intent of broadening the perspectives and experience on the council
123-SubA		to expand the duties and activities of the state Energy Efficiency and Resources Management Council and the state Renewable Energy Coordinating Board. The appointed members would more actively investigate energy activity in the state and advocate for renewable energy
136	5130	to use state taxpayer money to subsidize military installations by paying the city or town in which they are located 27% of the property taxes that they would pay if they weren't exempt
137	5552	to create "library assistance grants" that would send state taxpayer money to local libraries
138		to pressure law enforcement officers to lecture people smoking with children in the car when they pull them over
139		to force health care providers to use a brain monitor or pulse oximeter during any procedure for which the patient is put under general anesthesia
140	5461	to force all health insurers and medical plans to cover testing and treatment for temporomandibular joint disorder (which causes pain in the jaw)
141		to expand the role of the state Health Insurance Commissioner in pushing healthcare in the state away from a fee-for-service model in which providers are paid for services that they provide
146		to forbid landlords from asking potential tenants about their immigration status
149		to place on the next state election ballot an inquiry about whether employees should be free not to join unions or pay union dues
150		to give teachers the freedom to work without joining a union or paying any money in place of union dues. Individual teachers would have a right to negotiate their own terms with the schools in which they work
151		to present voters with a Constitutional amendment that would allow the passage of laws and Constitutional amendments by ballot initiative, bypassing the General Assembly and governor. The amendment would forbid voters from changing the state budget or limiting taxes within the Constitution, but it would not forbid them from increasing taxes and spending via statute
154		to require the House and Senate in the General Assembly to record video of all committee hearings and to post the videos online within 24 hours and for three years
171-SubA	5581	to give regulators the power to force dry cleaners to post prices for their services
172	5614	to create a "Port Marketing Collaborative" that would develop plans for ports across the state and determine ways to market them

177	5426	to forbid landlords from refusing to rent, or even discouraging people from seeking to rent, on the grounds that the potential tenants' pets are not "declawed or devocalized " The bill provides for a fine up to \$1,000, a period of probation during which the offender cannot own any pets or live on the same property as a pet owner, and forced "humane education "
178	5287	to force pitbull owners to take additional precautions for keeping their dogs, to forbid them from walking the dogs within 100 feet of a school, and to require them to carry liability insurance for the dog, with fines up to \$1,500
179		to free professional employer organizations of the requirement to remain bonded for an amount of \$50,000 if they have been registered with the state for at least two years
180		to adjust the state funding formula to redistribute state taxpayer money to lower-income cities and towns
181	5906	to add \$5 to traffic tickets to be given to the Department of Transportation for highway repair and maintenance
183	5088	to restrict state fiscal overseers, budget commissions, or receivers working in a city or town to financial matters, forbidding them from passing ordinances, resolutions, or charter revisions
188	5359	to end the seven-year phase-in of increased state aid for school districts that are scheduled to receive more, giving them the full amount immediately. The bill would also allow the municipalities to reduce their local "maintenance of effort" contributions to education by the amount of additional funding
190	5875	to increase the "tipping fee" for non-municipal vehicles disposing of waste at the Resource Recovery Corporation dump by \$2, with the money going to the town of Johnston
191	5090	to allow public charter schools access to state reimbursements for school housing costs independently of the school districts with which they may be associated
194		to force non-resident contractors working for the state to pay union-level wages to employees working on the project and to increase additional payment withholdings for any nonresident contractors doing business within the state from 3% to 5%, from which resulting taxes will be taken
199	5154	to force retailers of tobacco to post signage about the minimum age in Spanish, as well as English, and to add a sign in both languages concerning the health risks of the products
200	5613	to force health care insurers to calculate payments for mental illness and substance abuse treatment providers in the same way as other health care providers
201-SubA	5243	to forbid health insurance providers from considering gender when setting premium rates
207		to allow municipalities to tax new low-income housing at a rate higher than the state maximum if the city or town exceeds state requirements for the amount of such housing
212		to allow municipalities to count mobile homes when determining their percentages of low or moderate income housing
215		to limit the liability of government entities and employees in civil actions
216		to permit government employees to run for elective government office provided that they leave their jobs upon entering office

226, 366, 475	5341 & 6009	to make it more difficult to become a hoisting engineer by requiring three years of apprenticeship, with 6,000 hours of on-the-job training and 432 hours of training
227 & 476	5300	to force people who work with underground utilities, sewer lines, and storm drainage lines to become licensed by the state, with standardized testing and a biannual fee of \$200. They would also have to carry insurance and bonds
228	5598	to remove the requirement that an employee document a change in medical condition when applying for a resumption of workers' compensation benefits based on a recurrence of a prior condition
229		to increase the rate of pay that an employer must pay to an injured employee who is partially incapacitated from 75% to 85%
230 & 367	5508	to require employers to give 60 days notice before any transfer or mass layoff, with penalties of back pay or fines for a failure to comply
231	5889	to expand the state's temporary disability insurance program, paid for by taxes on Rhode Island workers' pay, to cover people who take time off from work to care for seriously ill family members or "to bond with a new child." In such cases, the employers must maintain health benefits for the employee and must return him or her to the prior job or its equivalent
232		to impose the same licensing requirements on microbreweries as apply to brewpubs
234	5105	to present voters with a Constitutional amendment that would limit elected officials in the Rhode Island House of Representatives and the Rhode Island Senate to three consecutive four-year terms
242	5416	to fix the price of tolls on the Newport Pell Bridge and forbid tolls on the Sakonnet River, Mount Hope, and Jamestown bridges, but to raise the funds for maintenance by increasing vehicle emissions inspection fees by \$20
243	5227	to exempt motorcycle trade-in values and insurance claims on damaged or stolen motorcycles from the state sales tax
246	5365	to completely eliminate the state sales tax, effective October 1, 2013
247		to increase the tax on cigarettes by approximately \$1.00 per pack, to impose a one-time "floor stock tax" on cigarette retailers and distributors that is 80% higher than the similar tax imposed in 2009, and to change the tax that distributors pay for cigarette stamps. This legislation would also create a fund of \$3.6 million paid to state agencies for a "tobacco control program"
249	5132	to expand the state's childcare subsidy to cover working families whose income increases above the cut-off point of 180% of the poverty level once they're enrolled. The new limit for such families would be 225% of the poverty level, which is currently around \$52,000 per year
252		to provide a \$99,600 credit on estate taxes, which is the equivalent of three times an exemption on taxes for estates up to \$1 million. This bill would also prevent the state tax from increasing along with the U.S. government's rate
253		to require state contracts to go to the lowest responsible bidder
254		to repeal recent sales tax impositions and increases on taxicabs and other transportation services, pet care services, and high-end clothing

260	5019	to ban the practice of "payday loans," which allow borrowers to borrow money against their future paychecks by writing a check that the lender will cash later, often at high interest rates

265		to require the state auditor general to review the financial activities of all government entities, with an eye toward cost savings, efficiencies, internal management, and other possible adjustments

268	5272	to give state taxpayer money intended to offset the motor vehicle excise tax to cities and towns based on their proportion of all vehicles, without regard to the tax rates that they impose on their residents' vehicles
269	5469	to expand eligibility for certain Medicare programs to disregard income up to 185% of the federal poverty level
270		to increase the state reimbursement rate for private developmental disability organizations' salaries from \$11.30 to \$12.03 per hour and adjust it by some measure of inflation going forward
271		to double the maximum part-time pay that retired public-sector nurses can receive as nurses or nursing instructors, to \$24,000
272	5411 & 6132	to prevent people from using, or stores from accepting, cash assistance funds for alcohol, lottery tickets, tobacco, pornography, guns, vacations, tattoos or piercings, jewelry, gambling, or government fees or fines and to make "food stamp trafficking" a crime
273		to increase the tax on cigarettes by approximately \$1.00 per pack. It is currently \$3.46
277 & 317	5818	to force all movie theaters that have at least ten screens to provide captioning for the deaf on at least one screen and audio descriptions for the blind
278		to expand the state's "parent deinstitutionalization subsidy programs" for those providing home care to include other family members than parents
279	5204-aa	to force all licensed "healthcare organizations" to put in place systems for "identifying patients or residents who could benefit from palliative care." This legislation would also create a new advisory board for palliative care within the Department of Health
280	5312 & 5976	to repeal the surcharge (tax) on medical imaging services
281	5418	to remove the authority of the Department of Health Board of Licensure to approve physician assistant training programs
282		to screen Medicaid, Rite Care, and Rite Share benefit claims and to analyze all transactions looking for fraudulent or incorrect claims; this bill would also add protections for technical software errors resulting in wasted money

287	5289	to begin interest payments on civil action judgments from the date that the actions are filed, not the date of the cause of action
288-aa		to give the Rhode Island Senate "advice and consent" authority over members of the parole board, and to limit those members to three terms of office
289		to allow city, town, or state police departments, or divisions of drug control, to keep any funds that they have confiscated and that have not been claimed within six months. This legislation would also remove the requirement that confiscated funds be kept in an interest-bearing account
290	5384	to add "juvenile program workers and shift coordinators" of the Department of Children, Youth, and Families (DCYF) to the definition of "peace officer," giving them the authority to detain, search, question, and arrest people whom they suspect of committing or intending to commit a crime
291	5180	to require police to obtain search warrants before they may search for information on portable electronic devices, with previously established exceptions
293-SubA	5472	to forbid any contractor that does not participate in an apprenticeship program, or that has not graduated at least three apprentices to journeyman status in the prior five years, from bidding on any local, state, or quasi-governmental public works projects over \$1,000,000
303-SubA	5451 & 5530	to ban "discretionary authority" clauses in health-related insurance contracts
304		to force telephone companies to delay international calls with a message that the "call may cost an additional surcharge or fee" and that other "service plans may be available that offer reduced rates "
305		to forbid banks from charging overdraft fees to clients' accounts when they write checks that their balances can't cover
306		to forbid health insurance companies from increasing their rates by more than the rate of inflation, without regard to the underlying causes of the increase
310	5917	to force state taxpayers to subsidize the tuition of illegal immigrants at Rhode Island public universities and colleges if they graduated from a Rhode Island high school or received a high school equivalency diploma from the state and if they pledge to seek citizenship
312	5911	to require mayors wishing to start "mayoral academy" charter schools in their cities or towns to procure the express approval of the city or town's school committee and municipal council
314	5874	to ban the placement of recyclable materials in the state central landfill and direct the Resource and Recovery Corporation to decide on the rules and regulations to enforce the mandate
318	5376	to force local school districts to provide students with CPR and defibrillator training, without any provision of additional state aid
322	5394	to exempt new construction from property taxes until a certificate of occupancy has been issued and somebody moves in to it
324	5151	to limit the time and reasons for which alcohol distributors can lend each other money and to require the lending company. to track delinquency and send notices. The legislation also requires businesses on a state delinquency list to pay for subsequent shipments in cash until the debt is paid
329		to reduce the length of time before a primary election within which a voter can switch party affiliations from 90 days to 29 days

351	5599	to prevent litigants from determining the appropriate rate at which to pay back money that they've borrowed to pursue a lawsuit, without regard to the risk that lenders accept with regard to the outcome of the case
352	5140	to make permanent the law that allows police to pull people over for not wearing a seatbelt as a primary offense
357		to forbid employers from asking potential employees whether they've ever been convicted of a crime
359		to allow anybody to vote, provided they know the name of a registered voter, by repealing the recently passed law requiring voters to show identification
362		to allow prior owners and tenants of a foreclosed property to remain on the premises until the property is sold
363	5078	to force a group of public employees to become unionized if a labor organization procures "authorization cards" from 70% of the group, also known as "card check " Employers and labor organizations would be permitted to file complaints alleging coercion of employees
364	5340	to force school departments to follow the commands of arbitration boards when they cannot come to agreement with labor unions about financial matters in a contract, commonly known as "binding arbitration "
365 & 777	5699	to automatically extend all government union contracts for firefighters, municipal police, teachers, and municipal employees for as long as it takes for a new contract to be negotiated
368	5388 & 5577	to make it more difficult for businesses to claim those doing work for them as "independent contractors" and to set "employee" as the assumed default for "any person performing work for or on behalf of another "
371	5468	to force mayoral academy charter schools to enroll their teachers in the state retirement plan, but to forbid them from enrolling their administrators
375	5471	to force state colleges and universities to provide hospital care and surgical-medical services benefits to adjunct faculty with at least a 50% course load
382	5298 & 5723	to give the Public Utilities Commission broad authority to regulate wireless companies in response to customer complaints about billing, sales, and quality
383	5401	to ease the security mandates for check cashers such that bulletproof glass and steel partitions would not be mandated in the law
388		to expand the definition of "alarm system" to include wireless systems and to change the fee structure for technicians' licenses, including fees for trainees and apprentices and a shorter period between mandatory renewals. This bill would also create a state Board of Examiners of Security Professionals to investigate licensing and renewals
391	5479	to seek a federal waiver that would allow the state government to raise the income limit for "family planning services and supplies" to 250%, or just under \$60,000 for a family of four
392	5412	to allow new companies tax deductions if they hire two employees. The legislation would allow a business to reduce a tax of its choice by 50% in its first three years of operation and 25% in its second three years

Explanation

The General Assembly Freedom Index by the RI Center for Freedom & Prosperity scores Ocean State lawmakers on their level of support for principles of freedom as proven by their votes on the floors of the House and Senate.

The index examines legislators' votes in terms of their likely effect on the free market, the size and scope of government, the balance of residents' interests against those of public employees and beneficiaries, and the constitutional structure of a divided government with limited power over the people whom it represents. The Center reviewed every bill submitted in either chamber and collected votes tallies for those that received roll-call votes on either floor. (Companion bills count once.)

The resulting scores give a detailed sense of each legislator's priorities beyond a few high-profile issues.

The Center further divided the bills into five categories:

- **Tax & budget:** bills that affect the tax structure in Rhode Island and/or that relate to government expenditures, just driving or relieving the pressure on taxation
- **Regulatory environment:** bills that make it more or less difficult to live and do business in the state by imposing regulations
- **Constitutional government:** bills that affect the structure of the government, as well as the scope of government in its authority over residents' lives
- **Public sector labor:** bills related to the relationship between the government's employees and itself and the electorate
- **Education reform:** bills that advance or impede the reform of the state's public education system, in terms of both cost and quality

Most legislation has implications for more than one of these categories. For the purposes of this index, we applied our subjective sense of the area of core effect and sorted the bills accordingly. If, for example, a bill having to do with education seemed to us intended to secure the role of public employees, we classified that bill as Public Sector Labor, not Education Reform.

Methodology

1) Determine weighting: Each bill received a weight ranging from +3 to -3, as determined by the RI Center for Freedom & Prosperity. Negative weights indicate legislation that creates or expands an agency, government program/function, or tax; creates new

regulatory burdens; is hostile to constitutional principles; or otherwise conflicts with the principles that guide the Center. Positive factors were assigned to bills in line with those principles. Companion bills in the House and Senate were weighted identically. The weightings used for this preliminary index will be finalized after the session through reviews of all chosen legislation by a panel of engaged Rhode Islanders with similar principles, and the combined the range of their results will produce final scores for release this summer.

2) Determine vote: Each legislator received a +1 or -1 vote factor, depending on whether he or she voted FOR or AGAINST a particular bill, respectively. If a legislator did not vote on a bill, he or she received a +0.25 if the bill passed or a -0.25 if the bill failed. Legislators who abstained from voting received a +0.75 or a -0.75 vote factor depending on if the bill passed or failed.

3) Calculate weighted vote: Multiplying the weighting factor and the vote factor produced a weighted vote score for each legislator for each bill.

4) Calculate the legislator score: The cumulative score for all bills for each legislator determined that legislator's overall score.

5) Calculate Freedom Index: Dividing each legislator's total score by the maximum possible for the appropriate chamber provided his or her Freedom Index, or a percentage of the best possible score he or she could have achieved. On a preliminary basis for 2013, the "perfect" scores are 27 for the House and 55 for the Senate, meaning that voting for all of the positive bills and against all of the negative bills would produce a "legislator score" of that number and a Freedom Index of 100.

To rank the legislators, the Center sorted them by their Freedom Index scores and then, in the cases of ties, by their scores in each category, in the following order: Regulatory Environment, Tax & Budget, Constitutional Government, Education Reform, and Public Sector Labor. When legislators' results were still identical, the Center adjusted them in order of their apparent stature and power within their chambers.

It should be noted that the complexity not only of the law but of political theory in general can make assessments of the sort described above subjective and very difficult. People reviewing the index should consider the results to be the best judgment of the Center, given our collected experience and expertise.
